Julie also arranged another successful Annual Tack Sale raising £498 for funds. Thanks to Diane, we had an excellent turn out for Afternoon Tea at Penny Farm, who greatly appreciated the extra footfall in January.

Liz and team attended the Sustrans Lune Valley Greenway "Roll into Spring" event to raise awareness of equestrians and a new banner was commissioned which can be used at future events.

Members turned out to help the Thwaite Brow Woods Conservation Project work party clear a popular bridleway.
